Frequently Asked Questions for Exclusive Offer – International

For Residents of Europe, Middle East and Africa

What does the Travel Seamlessly Offer include?

The Travel Seamlessly Offer provides a travel credit that may be applied toward eligible air travel, hotel accommodations, transfers, and other eligible travel arrangements booked through The Ritz-Carlton Yacht Collection. Subject to availability and the applicable offer terms, any unused portion may be applied toward designated onboard experiences, which may include eligible shore excursions, spa services, and onboard dining. The amount of the travel credit applicable to your booking will be disclosed before you complete your booking and confirmed in your booking documentation.

Who is eligible for the offer?

The offer is available for eligible new bookings by guests residing in participating markets in Europe, the Middle East, and Africa on select voyages, departure dates, and suite categories. Eligibility, participating markets, and the applicable credit value will be confirmed before booking. The offer is capacity-controlled and subject to availability.

Who can book air through The Ritz-Carlton Yacht Collection?

Guests with an eligible voyage booking may request qualifying air and other travel arrangements through The Ritz-Carlton Yacht Collection. Available services depend on the guest's departure market, itinerary, airline schedules, routing, applicable fares, and operational requirements.

How are my flights selected?

Flights are selected to align with your voyage itinerary, taking into account available routings, airline schedules, applicable fares, and operational requirements. We will seek commercially reasonable options that support timely arrival for embarkation. Guest preferences regarding departure airport, airline, and routing will be considered where reasonably practicable, but specific airlines, airports, routings, cabin products, and schedules cannot be guaranteed.

What airports are eligible?

The Air Program is generally available from major airports across participating markets in Europe, the Middle East, and Africa. Availability varies by departure market, itinerary, airline service, routing, applicable fares, and operational requirements. Your requested departure airport will be considered, but availability from a particular airport is not guaranteed.

Can I choose my travel dates?

We will recommend travel dates designed to support arrival before embarkation and alignment with the voyage schedule. Preferred dates may be requested and will be considered where reasonably practicable, subject to airline availability, routing, applicable fares, and operational requirements. Travel outside the standard travel window may be unavailable or may result in additional charges, which will be disclosed before the arrangements are confirmed.

Can I request a specific airline, flight or routing?

You may submit a preference for a particular airline, flight, or routing. We will consider the request where reasonably practicable, but it cannot be guaranteed. Any additional cost associated with an approved deviation or preference will be disclosed before confirmation.

Will my flight be nonstop?

Nonstop travel is not guaranteed. We will consider available routings that reasonably align with your voyage, but flight options remain subject to airline schedules, availability, applicable fares, market conditions, and operational requirements.

What happens if my flight is changed, delayed, or cancelled?

For air arrangements booked through The Ritz-Carlton Yacht Collection, we monitor relevant schedule information and, when a significant disruption affects your arranged travel, will provide assistance and coordinate available rebooking options in accordance with applicable carrier rules, the Booking Terms and Conditions, and applicable law. Guests should promptly notify us of any disruption and follow the contact instructions in their booking documentation. Nothing in these FAQs limits rights available under applicable law.

Can I earn or redeem frequent flyer miles?

Where permitted by the airline, we will request that your frequent flyer number be added to the reservation. Eligibility to earn miles, status credit, or other loyalty benefits is determined solely by the airline and is not guaranteed. Redemption of points and mileage upgrades is not available through The Ritz-Carlton Yacht Collection fares unless expressly confirmed in writing.

Can I use the travel credit if I arrange my own flights?

If you choose not to book air through The Ritz-Carlton Yacht Collection, the travel credit may still be applied to other eligible travel arrangements or designated onboard experiences for the same eligible voyage, subject to availability and the applicable offer terms. The credit may not be used toward the voyage fare or transferred to another booking or person. Eligible uses will be confirmed before booking.

What happens to the travel credit if I cancel or the voyage changes?

Treatment of the travel credit following guest cancellation, cancellation, or material change by The Ritz-Carlton Yacht Collection, or changes to associated travel arrangements is governed by the applicable Booking Terms and Conditions and mandatory law. Promotional restrictions do not limit any refund, alternative arrangement, or other right that cannot lawfully be excluded.

Does the travel credit expire or have cash value?

The travel credit must be used in connection with the eligible voyage and in accordance with the applicable offer terms. Except where required by applicable law, it has no independent cash value, is non-transferable, may not be sold or assigned, may not be applied to the voyage fare, and may not be redeemed for cash. Any deadline or forfeiture condition will be disclosed before booking.

Where can I find the full terms and my consumer protections?

The complete offer terms, Booking Terms and Conditions, organizer details, complaint contacts, and applicable insolvency-protection information will be available before booking and included or referenced in your booking confirmation. Nothing in the offer limits rights available under applicable consumer protection, package travel, or passenger rights laws.

Terms and Conditions for Residents of Europe, Middle East and Africa

Travel Seamlessly Offer Benefits are available on select voyages and departure dates for eligible new bookings by guests residing in participating markets in Europe, the Middle East, and Africa. Eligibility is subject to participating market, voyage, departure date, suite category, capacity, and availability.

The offer provides a travel credit that may be applied toward eligible air travel, hotel accommodations, transfers, and other eligible travel arrangements booked through The Ritz-Carlton Yacht Collection. The amount of the travel credit varies by voyage and suite category and will be disclosed before completion of the booking and confirmed in the booking documentation.

Air arrangements are subject to airline availability, schedules, routing constraints, applicable fares, cabin inventory, market conditions, and operational requirements. Guest preferences, including departure airport, airline, flight, cabin product, travel date and routing, will be considered where reasonably practicable but are not guaranteed. Any approved deviation, upgrade, or preference may result in additional charges, which will be disclosed before confirmation.

Subject to availability and applicable restrictions, unused travel credit may be applied toward designated onboard experiences for the same eligible voyage, which may include eligible shore excursions, spa services and onboard dining.

Except where required by applicable law, the travel credit has no independent cash value, is non-transferable, may not be sold or assigned, may not be applied toward the voyage fare, and may not be redeemed or exchanged for cash. The credit must be used in connection with the eligible voyage and within any deadline disclosed before booking.

Treatment of the travel credit and associated travel arrangements following guest cancellation, cancellation or material change by The Ritz-Carlton Yacht Collection, supplier disruption, or termination of the booking is governed by the applicable Booking Terms and Conditions and mandatory law. Nothing in these promotional terms restricts any refund, alternative arrangement, price reduction, assistance, compensation, or other remedy that cannot lawfully be limited or excluded.

The offer is available for a limited time and is capacity-controlled. The Company may modify, suspend, or withdraw the offer for future bookings at any time. Confirmed bookings retain the offer benefits applicable when booked, except for changes made in accordance with the Booking Terms and Conditions and applicable law.

The offer applies to new bookings only and is subject to the applicable Ticket Contract, Booking Terms and Conditions, airline or supplier terms, and any additional restrictions disclosed before booking. If these promotional terms conflict with mandatory law, mandatory law controls.

Frequently Asked Questions for Exclusive Offer for Residents of Australia

What does the Travel Seamlessly Offer include?

For an eligible new booking, the promotion provides a travel credit that may be applied toward eligible air travel, hotel accommodations, transfers and other eligible travel arrangements booked through The Ritz-Carlton Yacht Collection. Eligible uses, the credit amount, any included hotel night or transfer, and the terms applicable to your booking will be disclosed before you complete your booking and confirmed in your booking documentation.

Who is eligible for the offer?

The promotion is available for eligible new bookings by Australian guests on select voyages, departure dates and suite categories. Eligibility depends on the guest's market, point of sale, booking date, voyage, suite category, capacity and availability.

How much is the travel credit?

The amount depends on the eligible voyage and suite category and may be stated per person or per suite. The amount and basis applicable to your reservation will be disclosed before booking and confirmed in your booking documentation.

In what currency will the credit be provided?

The credit will be denominated in USD. For eligible bookings paid in Australian dollars, the AUD credit will be converted using The Ritz-Carlton Yacht Collection's approved fixed conversion rate of AUD 1.00 = USD 0.65, with the resulting amount rounded to the nearest whole Australian dollar. Currency conversion or card-provider charges imposed by third parties are governed by those providers' terms.

What can the credit be used for?

The credit may be used only for eligible services booked through The Ritz-Carlton Yacht Collection for the same eligible voyage. Eligible and excluded services, including any restrictions on air, hotels, transfers, shore experiences, spa, dining or other onboard purchases, will be disclosed before booking.

Can I select my airline, airport, route or dates?

You may request preferences. We will consider them where reasonably practicable, but airlines, airports, routings, schedules, cabin products and travel dates remain subject to availability, applicable fares and operational requirements. Any additional charge for an approved preference or deviation will be disclosed before confirmation.

What hotel and transfer benefits apply?

Selected suite categories may include one pre-voyage hotel night and transfers.

The eligible hotel, room type, transfer type, occupancy, inclusions and substitution terms will be confirmed in your booking documentation. All benefits are subject to availability and the applicable offer terms.

What happens if a flight or other arranged service is delayed, changed or cancelled?

For arrangements booked through The Ritz-Carlton Yacht Collection, contact us promptly using the details in your booking documentation. Available assistance, rebooking, refund, credit or other remedies depend on the circumstances, supplier rules, the Booking Terms and Conditions and applicable law. Nothing in these FAQs limits any right that cannot lawfully be excluded.

What happens if I cancel or change my voyage?

The treatment of the credit and related arrangements depends on the timing and reason for the cancellation or change, the terms accepted for your booking and applicable law. Any cancellation charge, loss of promotional benefit, refund, credit or alternative arrangement will be determined under those terms and mandatory law.

Does the credit expire or have cash value?

The credit must be used for eligible services connected with the eligible voyage by the deadline disclosed before booking. Except where applicable law requires otherwise, it is non-transferable, may not be sold or assigned, may not be applied to the cruise fare and may not be redeemed independently for cash.

Where can I find the complete terms?

The complete promotional terms, Booking Terms and Conditions, Global Ticket Contract, applicable air terms, contracting-entity details and complaint contacts will be available before booking and included or referenced in your booking documentation.

Terms and Conditions for Residents of Australia

Travel Seamless Offer Benefits are available on select voyages and departure dates for eligible new bookings by Australian guests. Eligibility is subject to guest residence, point of sale, booking date, voyage, departure date, suite category, capacity and availability.

The promotion provides a travel credit in the amount and on the per-person or per-suite basis disclosed before completion of booking and confirmed in the booking documentation. The credit may be applied only toward eligible services booked through The Ritz-Carlton Yacht Collection for the same eligible voyage.

Eligible and excluded services, including the treatment of air, hotels, transfers, shore experiences, spa, dining and other onboard purchases, are set out in the benefits matrix provided or referenced at booking. The credit may not be applied toward the cruise fare unless expressly stated.

For eligible reservations denominated in Australian dollars, the credit will be converted using The Ritz-Carlton Yacht Collection's approved fixed conversion rate of AUD 1.00 = USD 0.65, with the resulting amount rounded to the nearest whole Australian dollar. Refunds, reversals and third-party conversion charges will be handled in accordance with the Booking Terms and Conditions, the original payment method and applicable law.

Air arrangements are subject to airline availability, schedules, routing, applicable fares, cabin inventory, market conditions and operational requirements. Preferences will be considered where reasonably practicable but are not guaranteed. Approved deviations or upgrades may carry additional charges disclosed before confirmation.

Any included hotel night or transfer is subject to the hotel, room, occupancy, transfer and substitution details disclosed for the booking. Named properties and room categories are subject to availability. If substitution is permitted, the applicable standard and any guest remedy must be stated in the booking documentation.

Except where applicable law requires otherwise, the travel credit has no independent cash value, is non-transferable, may not be sold or assigned, and must be used in connection with the eligible voyage by the disclosed deadline.

Treatment of the credit and related arrangements following guest cancellation, voyage change, cancellation or material change by The Ritz-Carlton Yacht Collection, supplier disruption or termination of the booking is governed by the applicable offer terms, Booking Terms and Conditions and mandatory law. Nothing in these terms restricts any refund, replacement service, assistance, compensation or other remedy that cannot lawfully be limited or excluded.

The promotion is capacity controlled. The Company may modify, suspend or withdraw it for future bookings. A confirmed booking retains the promotional benefits accepted at booking, except for changes permitted by the applicable contract and law.

The promotion is subject to the applicable Booking Terms and Conditions, Global Ticket Contract, air terms and restrictions disclosed before booking. If these promotional terms conflict with mandatory law, mandatory law controls.
